NOTICE OF APPLICATION AND REQUEST FOR COMMENTS ON SHORELINE SUBSTANTIAL DEVELOPMENT AND SEPA MITIGATED DETERMINATION OF NONSIGNIFICANCE

Pursuant to RCW 90.58.140, WAC 173-27-110, and KMC 15.10.040, NOTICE IS HEREBY GIVEN that the **Port of Kalama** submitted applications on November 3, 2014 for a Shorelines Substantial Development Permit, Critical Areas Permit, and Grading and Excavating Permit. The project will also undergo review by Washington Department of Fish and Wildlife for a Hydraulic Project Approval and Nationwide Permit 12 verification from the US Army Corps of Engineers.

The project completes the construction of a 10,000-foot sanitary sewer force main system to provide sanitary sewer service for areas east of I-5. A pump station located at Haydu Park will pump wastewater through the force main to the City of Kalama's Meeker Drive pump station. The project will be located in Sections 31 and 32, Township 7 North, and Section 6 North, Township 6 North, Range 1 West of the Willamette Meridian. The sewer force main will be placed within existing city-owned rights-of-way along Kalama River Road and Meeker Drive, crossing the Kalama River on the Meeker Bridge. The application was determined complete on November 26, 2014, and a copy of the application material is on file for public review at the address listed below.

The public has the right to comment on the application, receive written notice of public meetings or hearings on the project, and/or receive a copy of the decision made on the application. Persons wanting to comment, request notice of meetings, or copies of decisions should send written comments or requests to: KALAMA CLERK-TREASURER, PO BOX 1007, KALAMA, WA 98625, within thirty (30) days of the date of this notice (see below). The Kalama City Council will take action on the shoreline permit at a public hearing to be scheduled after the close of the comment period. Interested parties have the right to appeal the Council's decision to the Shorelines Hearings Board per RCW 90.58.180.

As lead agency under the State Environmental Policy Act, the City of Kalama Department of Building and Planning issued a mitigated determination of nonsignificance (MDNS) on December 11, 2014. Copies of the MDNS, environmental checklist, and other application materials supporting this determination are on file with the City Clerk, and are available for public review between the hours of 8:30 a.m. and 5:00 p.m., Monday through Friday, except holidays. The public has the right to submit written comments concerning the project's environmental impacts. The SEPA comment period ends January 14, 2015.
