# CITY OF KALAMA CITY COUNCIL MEETING FEBRUARY 20, 2008

#### 1. OPENING

Mayor Pete Poulsen opened the City Council meeting at 7:03 p.m.

## A. Flag Salute

Mayor Poulsen led those present in the Pledge of Allegiance.

### B. Roll Call

Councilmembers present were Adam Smee, Dominic Ciancibelli, Chuck Hutchinson, Don Purvis, and Bud Gish. City staff present were Director of Public Works Carl McCrary, Clerk/Treasurer Coni McMaster, and Police Chief Bruce Hall. City Attorney Paul Brachvogel was also present. A. Appointments to the Parks & Recreation Advisory

#### Committee

#### B. Cowlitz County Parks Grant - Amount \$2500

Director of Public Works Carl McCrary informed the Council that an error was in the original agreement from the County which stated the grant was for \$5000, when in fact the grant is only for \$2500. The Council's previous approval is valid as the amount is less than was approved, so a new motion is not required. The record will show the grant is for only \$2500.

#### C. Police Station Relocation to the Community Building

#### D. Safe Schools Grant Agreement - Authorization to sign

Police Chief Bruce Hall explained this grant is in conjunction with a county-wide program for law enforcement and schools to work together. Councilmember Chuck Hutchinson made a motion the City Council authorize the Mayor to sign the Safe School Grant agreement with the School District. Councilmember Bud Gish seconded, and the motion carried.

#### E. Envision Kalama - Letter of Appreciation

Councilmember Dominic Ciancibelli requested a letter of appreciation to be signed by the Council be prepared and sent to Envision Kalama for their work on getting the trees for the downtown.

Mr. McCrary informed the Council that one of the Public Works employees, Danny Aumiller, has suffered a non-work related back injury, so he is off work at this time.
- B. Police Chief Bruce Hall reported he had attended a recent Chamber meeting and discussed the parking. The Chamber has decided to work on the issues and provide some feedback to him. There will be a meeting tomorrow night at 7 pm. The meeting will be held at the Montgomery House.
- C. Clerk/Treasurer Coni McMaster reported that AWC had used a picture of the Fir Street improvement project in an infrastructure report. Also, the City will receive reduced rates through the AWC Retro program based upon their good safety records. She noted the passing of local resident Frank Grey, who was a former City Council member.
- D. City Attorney Paul Brachvogel reported he had attended the AWC Conference in January.

under one roof. Councilmember Adam Smee seconded, and the motion carried.
