CITY OF KALAMA PLANNING COMMISSION JUNE 12, 2014

OPENING

1. Introduction of new City Planner

Co-Chairperson Kevin Wade introduced Matt Buchanan the new City Planner; he is taking the place of Matt Hermen. Also Brian Person of Group Mackenzie will be assisting Planner Buchanan with the updating of the estate lot floating zone and some other KMC code sections. The Commission welcomed both Planner Buchanan and Brian Person.

Co-Chairperson Wade asked the Commissioners and Administrator Smee for input on the direction they need to take.

Administrator Smee would like the Commission to finalize the large lot, but there are other areas in the KMC code like chapter 16 and chapter 11 that need to be addressed as well. Within those chapters it references sidewalk, curb and gutter and those need to be cleaned up so it matches the proposed language in the estate lot floating zone.

Commissioner Fortuna would like to see the information way in advance so the Commission has plenty of time to review it before the meeting.

1. Zoning for the proposed new annexation

Administrator Smee informed the Commission that a new proposed annexation has been submitted to the City. The property is located right next to Kamp Kalama on Meeker drive. He is suggesting that it be zoned mixed use. After some discussion Commissioner Mathison made a motion to have the zone be mixed use. Commissioner Ohall seconded the motion and the motion passed with all in favor.
