

ORDINANCE NO. 1383

AN ORDINANCE OF THE CITY OF KALAMA, WASHINGTON AMENDING THE 2016 BUDGET TO ACCOUNT FOR INCREASING THE BUDGET IN THE AMOUNT OF \$394,250.00

Whereas, the City of Kalama approved Ordinance No. 1371 adopting the 2016 Budget and 2016 – 2021 Capital Facilities Plan on December 2, 2015;

Whereas, the City of Kalama, having raised rates to meet the contract requirements has received additional revenues from Garbage rates which require additional contract fees be paid to the service provider Waste Control;

Whereas, the City's Police Department received grant funding and funds from the sale of assets which allowed for the purchase of new equipment increasing the budget in the Criminal Justice Fund;

Whereas, the City of Kalama was audited by the state for the years of 2013, 2014 and 2015 in September of 2016 which costs were more than anticipated in the original budget;

Whereas, the City of Kalama received a grant for and completed the work for the replacement of street lights with LED technology which will provide a cost savings in the future;

Whereas, the City of Kalama has accumulated funds in Water/Sewer Operations that will be used to make major improvements to the system in future years that needs to be transferred to the applicable reserve funds;

Now Therefore the City Council of the City of Kalama do ordain as follows:

Section 1 The 2016 Budget is increased to \$9,522,435 as shown on the attached Exhibit A including all transfers and adjustments to ending fund balance estimates.

Section 2 Acts taken by authorized officers and staff of the City, pursuant to this ordinance, but prior to its effective date are hereby ratified and confirmed. The appropriations made in this ordinance are necessary to accommodate the unanticipated revenues and expenditures.

Section 3 Severability - If any section, subsection, paragraph, sentence, clause, or phrase of this ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this ordinance.

Section 4 This ordinance shall become effective five days after passage, approval, and publication as provided by law.
