

CITY OF KALAMA CITY COUNCIL MEETING FEBRUARY 15, 2017

1. OPENING

Mayor Pete Poulsen opened the City Council meeting at 7:00 p.m. Mayor Poulsen led those present in the Pledge of Allegiance.

Councilmembers present were Mike Truesdell, Dominic Ciancibelli, Mike Dennis Langham, Rosemary Brinson Siipola, and Mary Putka. City staff present were Clerk/Treasurer Coni McMaster, and Acting Police Chief Steve Parker. Members of the public present are listed on the sign-in sheet.

4. PRESENTATIONS & AWARDS

A. Swear in Police Officer Kendrick Wong

Acting Chief Steve Parker introduced new Officer Kendrick Wong who has 20 years of police experience in Hawaii, Washington, Alaska, Idaho and Wyoming. Clerk/Treasurer Coni McMaster administered the oath of office to the Officer Kendrick Wong. The Mayor and Council welcomed him to the City.

6. PUBLIC COMMENTS/CONCERNS

Kalama Citizen Mike Reuter provided a packet of information to each of the Council regarding the proposed Methanol plant. He informed the Council that his concerns with the plant started from the beginning with is dislike of the plume the plant would produce and the effect on his views of the river, but after much more research he believes there are many more reasons to not support the proposed plant here in Kalama. In his research, he has found reports that say China is buying up gas resources all over the world in an effort to control certain industries. They have control of the market in Australia. If they get this pipeline, they will have control of the product in this region and along the 15 corridor. There will no additional capacity available for other industries to build or grow. Mayor Poulsen asked if this is a fact, why aren't more large businesses objecting to the proposal or why Williams Pipeline would let the resource be monopolized. Mr. Reuter wasn't sure but commented that maybe Kalama isn't big enough to be on their radar. He thinks Williams will use the lack of capacity for more to either build more lines or raise prices in the future as they are already behind in what they can provide to Portland and other areas. Mr. Reuter stated that this is the first place he has shared this information and will be going to the County next. He will also try to contact the governor. He noted that China owns the gas fields in Canada which is where the gas coming through the pipeline will come from. Mayor Poulsen thanked 2017-2-15Minutes

Mr. Reuter and said he would read the material provided.

Resolution No. 650 was read by title: A Resolution of the City Council of the City of Kalama authorizing the City to enter into a Loan/Grant Agreement (Wqc-2017-Kalama-00161) with Washington State Department of Ecology to cover the costs of the Kalama General Sewer and Wastewater Facilities Plan in the amount of \$100,000. Councilmember Rosemary Siipola made a motion the Council adopt Resolution No. 650. Councilmember Mike Truesdell seconded, and the motion carried.
