A RESOLUTION DECLARING THE CITY'S INTENT TO ANNEX CITY KALAMA CLOVERDALE PUMP STATION PROPERTY – PARCEL NUMBER WC2801012 AS DESCRIBED HEREIN UNDER RCW 35A.14.220 AND 35A.I 4.300, AND AUTHORIZING THE CITY STAFF TO SUBMIT THE NOTICE OF INTENT TO THE COWLITZ COUNTY BOUNDARY REVIEW BOARD

WHEREAS, the City of Kalama purchased the rural property along Cloverdale Road in 2013 for the sole purpose of building a new water pump station to improve the City provided water service to the area residents;

Lot 1 of Short Subdivision NO. CC 12-005, as recorded May 7, 2013 in volume 16 of Short Plats, Page 139, Under Auditor's File No. 3479327; being a portion of the Northeast Quarter of Section 28, Township 6 North, Range 1 West, W.M.

and on the attached Exhibit A and as shown on the attached map as Exhibit B to the Cowlitz County Boundary Review Board for consideration and thereafter and upon such action, to be returned to the City of Kalama for final action to finalize the annexation
