### A. Antique District Association - Tourism Funding

Mayor Pete Poulsen informed the Council as part of the budget for the City's tourism funds in 2013, the City approved \$500 for the highway sign for the Antique District. Policy is that the City reimburses the organization after the payment has been made. The Antique Association has requested that the City pay the \$500 directly to DOT along with the share from the Association. This is the first time the Association requested and received funding.

A *motion was made* by Councilmember Purvis to approve the direct payment of \$500 to DOT on behalf of the Antique Association for the I-5 signage as approved in the tourism budget. Councilmember Truesdell seconded the motion and the *motion passed* all in favor.

They were able to find significant savings in the aftermarket emergency equipment compared to previous vehicle purchases. Another impound hearing was decided in the City's favor. School is back in session Sept. 3rd, and a vehicle seized over 2 years ago is now being auctioned off.

She also reported that the building department has been very busy with new home construction and the plans for the Port of Kalama Interpretive Center have been dropped off for review.
