A. Ordinance No. 1315 – Budget Amendment – Ranney Well Maintenance Funding

Ordinance No. 1315 was read by Title - An Ordinance of the City of Kalama, Washington amending the 2013 Budget to include unanticipated revenues and expenditures for rural economic development funds for maintenance and improvements to the Ranney Well increasing the Budget in the amount of \$70,000. Councilmember Dominic Ciancibelli made a motion to accept Ordinance No. 1315 as read. Councilmember Mike Truesdell seconded, and the motion carried. The City received funds from Cowlitz County to fund the project.

B. Ordinance No. 1316 – Nuisance Code Amendment

Ordinance No. 1316 was read by Title - An Ordinance of the City Council of the City of Kalama, Washington, amending portions of Kalama Municipal Code Section 7 pertaining to nuisance abatement. City Administrator Adam Smee explained that this ordinance is to clarify the code provides the City the ability to enforce the issues regarding blight as recommended by the City Attorney. Councilmember Dominic Ciancibelli made a motion the Council adopt Ordinance No. 1316 as read. Councilmember Mary Putka seconded, and the motion carried.

- A. City Administrator Adam Smee noted the State Auditors are in the office and keeping Coni busy. He and Coni had attended a budgeting conference two weeks ago obtain some useful information.
- **B.** Superintendent of Public Works Kelly Rasmussen presented a written reported. He highlighted items regarding increasing the Port zone pressure reducing valve which provides better service to the Port areas and other outlying areas such as Kress Drive, and the new WWTF microscope with camera that allows our operators to work with DOE in Olympia to better address compliance issues. He also noted that the crew and Field Supervisor Chad Moon did a great job while he was off on a two week vacation.
- **C. Police Chief Randy Gibson** presented his statistical report. He noted 7 cases listed were related to the theft of lawn ornaments and furniture which was solved and many items returned. In this case some of the thefts had not been reported. Misdemeanor charges are pending and Chief Gibson expects the case will be pled out. The other item highlighted was the motorcycle pursuit that ended in arrest and drug charges. Chief Gibson reported the sale of the seized vehicle from 2 years ago which sold for \$760.
- **D.** Clerk/Treasurer Coni McMaster provided the preliminary August Treasurer's report which indicates the City is currently doing well. She also noted that Auditors are reviewing many items so that is time consuming. She is preparing the preliminary budget draft for the Department Heads to work from. She and Adam would like to have a budget workshop prior to the next meeting and that is on the consent agenda for approval.
