

**TERMINATION OF
INTERLOCAL AGREEMENT FOR OPERATION, MAINTENANCE AND
PARTICIPATION IN COWLITZ COUNTY COMMUNICATIONS CENTER
EFFECTIVE JANUARY 1, 2019, ASSUMPTION OF COMMUNICATION
DUTIES BY COWLITZ 911**

BACKGROUND

WHEREAS, Cowlitz County, Washington, the Cities of Longview, Kelso, Castle Rock, Kalama and Woodland, Cowlitz County Rural Fire Districts 1, 3, 5 and 6, and Cowlitz 2 Fire and Rescue are parties to the above-named interlocal agreement; and

WHEREAS, on March 13, 2018, the Cowlitz County Board of Commissioners adopted Cowlitz County Ordinance 18-014 which created the Cowlitz County 911 Public Authority (“Cowlitz 911”), an independent legal entity exclusively responsible for its own debts, obligations, and liabilities, and approved an initial charter; and

WHEREAS, Cowlitz 911 is prepared to assume all duties of the Cowlitz County Communications Center, effective as of 00:00 (military time) Pacific Standard Time (PST) on January 1, 2019; and

WHEREAS, the parties to the above-named interlocal agreement now wish, in accordance with paragraph 9 of said agreement (Agreement Alterations and Amendments), to terminate the said agreement, effective 23:59:59 PST on December 31, 2018.

AGREEMENT

NOW THEREFORE, in consideration of the terms and conditions hereinafter set forth and in consideration of the obligations of the other parties here, each of the parties hereto promises and agrees as follows:

1. The above-named interlocal agreement is terminated, effective as of 23:59 PST on December 31, 2018.
2. This agreement shall be filed pursuant to the requirements of RCW 39.34.040.
3. Cowlitz County shall execute the original of this agreement. Each other party hereto shall sign a counterpart of the original of this agreement. The parties hereto intend that all the signed counterparts taken together with the original will be considered as one original document and given full force and effect as if all the parties had signed one document.
