 - A. Ordinance No. 1308 Parking Code Update

City Clerk/Treasurer Coni McMaster read Ordinance No. 1308 by Title: An Ordinance of the City of Kalama, Washington revising Kalama Municipal Code Chapter 10.08 Parking Control in its entirety to address parking issues and establish regulations in all zones of the City. City Councilmember Don Purvis made a motion the City Council adopt Ordinance No. 1308 as read. Councilmember Mike Langham seconded, and the motion carried.

10. MAYOR & COUNCILMEMBER REPORTS

available. He is also working on package deals with the Red Lion for the Blues Festival in August.

- **E.** Councilmember Donald Purvis informed the Council that this weekend the County Emergency Management will be holding a regional disaster preparedness exercise.
- F. Councilmember Mary Putka reported the Wine Chocolate Blues Event fundraiser for the Community Building is on track and Envision has donated funds to help.

11. <u>DEPARTMENT REPORTS</u>

- **A.** City Administrator Adam Smee reported that the Annual Report review was completed and the report filed with the State Auditor.
- B. Superintendent of Public Works Kelly Rasmussen presented a written report noting last week's power outage where all the back-up generators kicked in and worked as planned. If a major event occurred, the City will be able to coordinate all activities from the City Shop building. He did note that the Old 99 Pump station does not have a generator, so this had to be attended to manually. Kelly added that he has hired another summer worker for grounds keeping. He also thanked members of the Garden Club for work they did downtown.
- C. Police Chief Randy Gibson presented his statistical report. He noted that the City has been a victim of credit card fraud and that investigation is on-going. All credit cards have been collected and will be destroyed and replaced. Chief Gibson added that the Police have helped with several nuisance items as well. Mayor Poulsen asked a question about the government proposal to drop the DUI limit and the effects it will have on local jurisdictions which led to a discussion of the likelihood of passage and the burden it will create.
- **D.** Clerk/Treasurer Coni McMaster noted the completion of the Annual Report along with the annual Street and Library reports, and the annual Salary Survey. She noted there has been cross training for her duties as she will be out of the office for a month and Deputy Clerk Sue Seay will be filling in.
