Subject: Library Update

The Kalama Library remains closed. Given the Governor's reopening plans, I think it unlikely we will

reopen until mid to late June. After closing the door on March 18, Carol and I were able to accomplish a

number of tasks, primarily housekeeping and organizing. I have been working 5-7 hours a week, either

from home or in the Library. I check email and phone messages, check in, shelve returned books and update the website.

I have two online meetings next week. The Cowlitz Directors meeting is on Tuesday. Carolyn Peterson,

from WA State Library is leading a meeting on Thursday, specifically for the smaller libraries. Both

meetings center on reopening plans. Kalama will certainly look different from Longview or

Kelso. Carolyn's idea to meet with the smaller libraries is a good one.

Carol and I have been discussing our ideas on how to reopen Kalama and are working on a plan. I will share that when we get it on paper.

I placed two book orders this week, representing new March and April books. When the books arrive, $\ensuremath{\text{I}}$

plan to have Carol come in and we will get the books entered into KOHA, process them, get them ready to shelve.

Adam: Regarding the \$2,000 grant from Bluescope that we hope to use for more shelving, I was in

contact with Cameron Stone from Workpointe prior to the shut-down. We traded some plans and ideas $% \left(1\right) =\left(1\right) +\left(1\right) +$

and will I pursue that when possible.

Regarding the Rural History Grant 2019-20, obviously, we have not been able to continue that work. It

will expire at the end of August; we are hopeful we can do more scanning and recording. It is unlikely

there will be an extension. There is a new grant cycle for 2020-21, and we plan to apply. Carol is doing

some preliminary work on writing that grant proposal.

I've had conversations with Ruthie Tippin about the Summer Reading Program. I've passed some

resources on and we will be meeting soon to discuss options. There will not be any group gatherings, no

Storytime. Everything will be "virtual" and online. We will make it work. This is an incredibly popular program.

Many of our patrons are using the Washington Anytime Library to access ebooks and audiobooks. This

service is free with a library card. There is also a program offering free access until June 30. To date, 17

patrons have signed up. I call each person, offering assistance if need be, and also encourage them to

sign up for a card when the programs ends.

This program, as well as information for online programs for kids, is all detailed on our website. I had an update on the census yesterday.

While I am anxious to get the Library open, the health and safety of my staff absolutely remains my

priority. We will have strict procedures in place and I am confident our patrons will comply. I will not

tolerate any behavior that jeopardizes our safety.

WI-Fi update:

Kalama Public Library is participating in the program outlined below in the press release. Kalama Phone

has set it up, extending our WI-fi capability. I have heard numerous times that the existing WI-fi signal is

weak and unreliable outside the building. The new network is called: Library Drive-in WI-Fi. Currently,

the signal is strongest on the south side of the building. Kalama Phone will be experimenting with

different configurations to extend the signal to the front of the building. It is set up on a timer, available 6 AM to 10 PM.

If there are any problems associated with this, we can change the timer. I do know people have been

using the existing WI-fi to some extent. I'm not sure if that network (kalamalibrary) is on a timer or not.

(I have been unwilling to drive down at midnight to test that out!)

I sent this same information to Ralph, who has copied his officers, so they are aware of the possibility of increased usage.

Drive-in Wi-Fi hotspots launch statewide push for universal public access broadband * May 7, 2020

Public-private partnerships seek to bridge the "digital divide" by providing free broadband access to all Washingtonians through community drive-in Wi-Fi hotspots

OLYMPIA, WA - The Washington State Broadband Office estimates over 300 new drive-in Wi-Fi hotspots

are coming online statewide through an initiative to bring free public broadband internet access to all

residents. Partners in the state's drive-in Wi-Fi hotspots project include: Washington State University;

Washington State Library, part of the Washington Office of the Secretary of State; members of the

Washington Public Utility Districts Association (WPUDA) and affiliated nonprofit Northwest Open Access

Network (NoaNet); the Washington State Broadband Office; Washington Independent

Telecommunications Association (WITA); Washington Technology Solutions (WaTech); and the Office of

the Superintendent of Public Instruction (OSPI). Microsoft and the Avista Foundation are providing

funding, and a national nonprofit contributed equipment and installation.

To date, 140 of the new drive-in hotspots are operational, in addition to 301 existing Washington State

Library hotspots identified across the state. All told, some 600 public hotspots will soon be available to keep Washington communities connected.

For complete information and a map of locations, visit www.driveinwifi.wa.gov. The map will be updated as more sites come online.

Launching primarily as parking lot hotspots in response to the COVID-19 pandemic, the free community

Wi-Fi is accessible regardless of how users arrive at the locations. Some sites also offer indoor public

access during business hours. Everyone using the sites – outside or inside – must practice social $\,$

distancing and hygiene precautions, including staying in your vehicle or at least six feet from other users and wearing a mask if necessary.

Each hotspot will have its own security protocol. Some will be open and others will have Children's

Internet Protection Act (CIPA) safe security installed.
