## **RESOLUTION NO. 697**

A RESOLUTION OF THE CITY OF KALAMA, COWLITZ COUNTY, WASHINGTON, REPLACING RESOLUTION NO. 671 SETTING FEES FOR BUILDING PERMITS AND RELATED MATTERS AS OF JANUARY 1, 2021

**WHEREAS** the City Council annual reviews fees and fees for building permits and related matters have not been updated since 2018;

**NOW THEREFORE** be it resolved by the City Council of the City of Kalama adopts the building fees as follows:

**SECTION 1: Residential** Building Permit Fees. Fees for building permits are due at the time of permit issuance and shall be calculated according to the table below:

SECTION 2: Commercial/Industrial Building Permit Fees. Fees for building permits are due at the time of permit issuance and shall be calculated according to the table below:

**SECTION 3:** Plan Review Fee. The fee for reviewing plans for building permits is 65 percent of the building permit fee paid at the time of plan submittal. If an applicant submits all at the same time, plans for identical buildings for one or two-family dwellings under the International Residential Code, the plan review fee shall be 50 percent of the plan review fee for the first one submitted. These fees are in addition to the permit fees in Section 1.

**Section 5.** Excavation and Grading Permit Fees. Plan Review fees are 65% of the permit fee – Required for any project over 100 cubic yards. The fees are calculated according to the table below:

Section 9. Washington State Building Code Surcharge

For Projects permitted under the IBC or IEBC: \$25.00

For Projects permitted under the IRC: \$6.50 for each Permit issued PLUS \$2.00 per additional Unit after the first.
