#### ARE YOU PREPARED FOR AN EMERGENCY?

As we move into autumn and winter, it's time to reassess your emergency preparedness plan. The Cowlitz County Department of Emergency Management has the detailed information available at <a href="https://www.co.cowlitz.wa.us/709/Preparedness">https://www.co.cowlitz.wa.us/709/Preparedness</a>. They offer preparedness fliers with information for a 72-hour preparedness kit, home generator

It's important for your family to have a plan, which may include sheltering in place and



supplies to have on hand to get through at least 3 days. Water and food, medications, flashlights, a battery-operated radio, and first-aid supplies are just some of the items you may need. #### **REMINDER: SUMMER SEWER AVERAGE HAS ENDED**

City Residents: The summer sewer average has ended. What does this mean for you? Your sewer will be billed based on the full amount of your water consumption. Every drop of water has a sewer charge associated with it. For the "summer months" between the May meter reading and the September meter reading the sewer charges are averaged based on the other 8 months of your metered consumption and ten percent is added to this consumption. What's the benefit? If a customer goes over this consumption amount, the sewer will be billed at the average plus 10% consumption and nothing more. The City does this to give a break to residents for watering lawns and gardens, etc. during those warm summer months. The water portion of the bill is billed the same all year. You are still welcome to water as much as necessary, but please be aware your utility bill will be affected. Note: This is not for industrial or commercial users of sewer. #### WATVS ON CITY STREETS



The City of Kalama has passed a new municipal code that now allows a person with a valid driver's SPEED LIMIT

license issued by the state of their residence to operate a wheeled all-terrain vehicle (WATV) upon a city street having a speed limit of 35 miles per hour or less. Here are some frequently asked questions and answers regarding the new code:

**Q**: What's the definition of a WATV? Does that include side-by-sides <u>and</u> 4-wheelers? **A**: The new code <u>does not allow</u> for the operation of <u>4-wheelers</u> on city streets. A WATV is defined as a four wheeled vehicle where operator and passenger sit <u>side by side</u> in the vehicle, manufactured primarily for recreational non-highway all-terrain use, as further defined by the state Model Traffic Ordinance adopted by the City of Kalama (KMC Chapter 10.04.010). The new ordinance only allows for properly registered and certified

Q: Do I have to wear a helmet if I operate a WATV on city streets?

**A:** Not if the WATV is equipped with an Original Equipment Manufacturing (OEM) Roll Over Protection System (ROPS). Otherwise, helmets are required.

**Q:** What if my WATV isn't equipped with seatbelts?

side-by-side WATV's to operate on city streets

**A:** All occupants of a WATV shall wear safety belts, even if not provided by the manufacturer. Also, child restraints are required in accordance with RCW 46.61.687. Rule of the thumb—if the child belongs in a child restraint device or booster in a car, the same applies in a WATV.

Q: What kind of registration or certification do I need to operate a WATV on City streets? A: A person may only operate a WATV on City streets with the appropriate, current, and proper on-road vehicle registration affixed to the rear of the WATV (see RCW Ch. 46.09.442), and meet all equipment requirements, be certified by a Washington State licensed WATV dealer or motor vehicle repair shop, and declaration requirements in accordance with RCW 46.09.457. Documentation of a safety inspection required by RCW 46.09.457(1)(b)(i) must be carried in the vehicle and provided to a duly licensed law enforcement officer upon request.

Operators of WATV's must obey all the rules of the road that any other motor vehicle is required to obey. All motorists are urged to exercise caution when operating WATV's or when operating a motor vehicle around WATV's on city streets. ### THE MORATORIUM HAS ENDED

The State Utility Moratorium ended on September 30th, 2021 and will not be extended. While it prohibited utility services from being disconnected for non-payment, it did not relieve customers from the obligation to pay for the utility services. The City will continue to work with customers provided they communicate with the City and act in good faith to resolve any past due balances. Failure to communicate by October 10th or adhere to any agreement made will result in further actions such as additional fees, disconnection of service, or other legal remedies. The City can set up a payment plan for the past due balance that will spread the payments out for a period of 3 months up to a maximum of 18 months depending on the amount of the outstanding balance, the average monthly bill, and reasonable amount the customer feels they can pay. Late fees are waived during the period covered by the payment plan, provided timely payments are made. If you're a renter, the landlord will need to approve the payment plan prior to finalization.
