### CITY ADMINISTRATOR'S UPDATE

Let's talk about **housing in Kalama**. People have mixed feelings about development and growth. Often, we fear that more homes and a resulting larger population will compromise the charm and character of Kalama, but a larger population better supports our business community and increases economic vitality. There has been increasing demand for housing in Kalama over the last 10 years as more people discover the amenities our small city has to offer.

#### How do we balance providing housing to meet the demand while protecting our identity as a community?

Much of this protection comes from the land use rules established in Kalama's zoning and development code. The Planning Commission serves as an advisory body that crafts, reviews, and updates the language of the zoning and development code to be presented to the



City Council for final adoption as part of the Kalama Municipal Code (KMC).

The Planning Commission also provides preliminary review and recommendations to the City Council for subdivision and other development applications based on the rules adopted in the KMC. This is called preliminary subdivision (plat) review.

The Lofts at Kalama (TLK) is a significant multifamily housing subdivision which came before the Planning Commission most recently and spent multiple meetings in public hearing to capture the concerns raised regarding this new development concept for Kalama. After the public hearing, the Planning Commission weighed the testimony and the application against the KMC on the sections governing subdivision development to make a recommendation to City Council for adoption or rejection of the design concept. Often, Planning Commission implements conditions of approval to ensure community concerns are addressed, but an applicant's property rights are preserved. An example of a condition of approval might be: "We recommend approval of the application for 25 units, but as a condition of approval, the developer will build a 7,000 square foot park with playground equipment and dedicate it to the city."

The subdivision chapter of the KMC provides guidance for what is required in a development application. The code also gives the Planning Commission the authority to ask for public improvements to accommodate the development's impact. Some of the standards are firm rules in the code and some of the standards are discretionary. In the example of the park, above, recreational areas proportionate to the increased density of the development are to be provided and paid for by developers (a firm rule from the code), but the size of the park and what it must contain is discretionary and the Planning Commission gets to set that recommendation.

December 31 <sup>st</sup>	6:00pm – 1:00am (on January 1st)
