**CORRESPONDENCE**

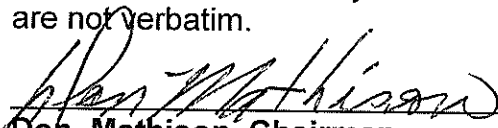
