KALAMA CIVIL SERVICE COMMISSION REGULAR MEETING July 28, 2022

CALL TO ORDER

The meeting was called to order at 5:30 p.m. In attendance were Commissioner Lynn Hughes, Commissioner Dan O'hall, Secretary Krystall Marriott, and Chief Ralph Herrera. Chairman Lloyd Corgan was absent.

APPROVAL OF MINUTES

Commissioner O'hall presented the minutes from the June 23, 2022 and July 7, 2022 meetings. Commissioner Hughes made a motion to approve the minutes as presented, Commissioner O'hall second and the minutes were approved.

OLD BUSINESS

Secretary Marriott informed the Commission that she has heard back from the City Attorney regarding the review of Civil Service Rules. He said he had about 20 more pages to review and would be completed by the end of next week. Once the rules are returned, they will be sent to City Hall, then to the Guild for review before the Commission can give their final look over for approval.

Commissioner O'hall proposed that the Commission approve the new Lateral List, Commissioner Hughes seconded, and the list was approved.
