KALAMA CIVIL SERVICE COMMISSION REGULAR MEETING SEPTEMBER 27, 2018

CALL TO ORDER

Chairman Don Mathison called the meeting to order at 5:30 p.m. Commissioner Levi Morgan, Commissioner Gary Finley and Secretary Krystall Marriott were in attendance. Also in attendance were Chief Ralph Herrera and members of the public.

APROVAL OF THE MINUTES

Chairman Mathison asking the commission if there were any motions to approve or amend the meeting minutes from April 26, 2018, June 6, 2018, and June 14, 2018. Commissioner Finley made a motion to approve, Commissioner Morgan Second and the motion was carried.

NEW BUSINESS

Also, she asked if there needs to be a process for Full Police Clerks, as in the past when the position became full time it was questioned. Secretary Marriott will request information from MSRC.

Discussion took place that a workshop would need to be held to start the process of looking at updating the rules. It was agreed that the next meeting would be October 25, 2018 at 5:30pm.

CORRESPONDENCE

Chief Ralph Herrera notified the commission that Scot Edgworth would be removed from the Advanced Entry Lateral list as he has chosen to move back o Minnesota. This would leave the Lateral and Advanced Entry Lists empty, and would leave the only option to move into the Entry Level List for new positions for an addition within the next 3-45 days. The top 3 are currently being moved into background checks.

Also, given to the Commission was Officer Kendrick Wong's retirement letter.
