This ensured the panel was consistent in its conclusions.

The strongest candidates were on the final day of the interviews. The top three candidates were stellar. When asked what should be done to improve the process, Dan Ohall indicated he had been part of the evaluation for the Chief and part of a panel for the Fire Department. He said of all the panels, this one was the best. He really appreciated the comments from the Chief on key points for each question. His one concern is Kalama does not have an immediate opening, and will most likely lose the top candidates to other agencies.

Don Purvis agreed the Chief's comments were invaluable. He also appreciated that questions touched on key issues, such as marijuana. It was also interesting to hear what the candidates knew about Kalama.

Chairman Rosson thanked Dan and Don for their assistance in the process. He said there are grants out there for hiring he hopes the City will pursue. There was a brief discussion regarding location of the new police department. It was felt citizens should be asked for their input.
