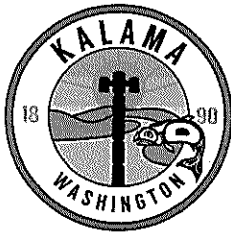

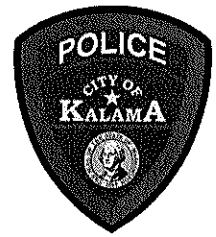

February 22, 2021

CALL TO ORDER

Chairman Don Mathison called the meeting to order at 5:00 p.m. Commissioner Lloyd Corgan and Secretary Krystall Marriott were in attendance. Commissioner Gary Finely was absent.

APPROVAL OF MINUTES

Chairman Mathison presented the minutes from January 19, 2021 meeting. Chairman Mathison made a motion to approve the minutes, Commissioner Corgan second and the minutes were approved.

NEW BUSINESS

Secretary Krystall Marriott asked permission to remove Jeremy Almond from the Advanced Entry Level List as he withdrew his name. Ms. Marriott also requested permission to remove Robbie Satterly after March 15th, as that will be his hire date for the department. Chairman Mathison made a motion to remove Almond and Satterly from the Advanced Entry Level List, Commissioner Corgan second and both names were removed.

Ms. Marriott informed the Commission that a new applicant named William Rogers has applied with the Kalama Police Department. He would qualify for the Lateral List, as he has been working for the Tribal Police in Chehalis/ Centralia area. Currently there are no openings in the department, however, they are possibly anticipating a possible opening the middle of April. Chairman Mathison made a motion to add William Rogers to the Lateral List, Commissioner Corgan seconded, and the motion was carried.


OTHER
